

#### **Definition of Ethics**

## "Ethics is doing the right thing even when no one is watching."

During the 1984 Sikh genocide, when thousands lost their livelihoods as their trucks were destroyed by mobs, **Ratan Tata** quietly gave away new trucks to Sikh genocide survivors without charging a penny. This act of humanity was done without publicity or expectation of recognition, helping them restart their businesses from scratch.

## "Ethics is the difference between 'Can I?' and 'Should I?'"

IAS Officer Ashok Khemka in 2012 cancelled a land deal between Robert Vadra and DLF in Haryana. While the deal was legally approved and he could have let it pass, Khemka asked should he allow what appeared to be corruption and misuse of political influence. He chose to act on ethical grounds despite potential career consequences.



Vijay Pandhare, Chief Engineer in Maharashtra's Water Resources department, exposed a Rs 120 billion irrigation scam in 2012. It would have been easy to stay silent and keep his comfortable position, but he chose the difficult path of revealing that 99% of the 227 irrigation projects were either nonfunctional or never commenced, leading to the resignation of Deputy Chief Minister Ajit Pawar.

## "Ethics is the philosophical compass that guides us between right and wrong."

When **Arjuna** faced the moral crisis of fighting his own relatives in the Kurukshetra war, Lord Krishna provided ethical guidance through the Bhagavad Gita. Krishna's teachings on duty, righteousness, and moral decision-making became the philosophical compass that guided Arjuna to fulfill his responsibilities as a warrior while maintaining his moral integrity.



#### Schools of Thoughts in Ethics Normative Ethics (What ought to be done)

- Mahatma Gandhi's principle of Ahimsa (nonviolence) is a normative ethic, prescribing nonviolent behaviour as morally right.
- Supreme Court mandates that politicians must declare criminal cases - establishing moral duty for transparency







Level/Stage	Age Range	Description
I: Obedience/Punishment	Infancy	No difference between doing the right thing and avoiding punishment
I: Self-Interest	Pre-school	Interest shifts to rewards rather than punishment – effort is made to secure greatest benefit for oneself
II: Conformity and Interpersonal Accord	School-age	The "good boy/girl" level. Effort is made to secure approval and maintain friendly relations with others
II: Authority and Social Order	School-age	Orientation toward fixed rules. The purpose of morality is maintaining the social order. Interpersonal accord is expanded to include the entire society
III: Social Contract	Teens	Mutual benefit, reciprocity. Morally right and legally right are not always the same. Utilitarian rules that make life better for everyone

### Rumble in the Jungle: Remembering the epic George Foreman-Muhammad Ali fight

Heavyweight boxing legend George Foreman passed away on Friday. He was 76

Why in News? George Foreman, boxing legend known for the iconic 1974 "Rumble in the Jungle" against Muhammad Ali, has passed away, marking the end of an era in boxing history.



#### Ethical Lessons from George Foreman-Muhammad Ali Fight Moral Courage and Integrity

- 1) Ali sacrificed nearly four years of his career peak by standing against the Vietnam War
- 2) Lost titles and boxing license but remained committed to his beliefs despite personal cost
- 3) His principled stance became integral to his legacy beyond athletics

#### **Justice and Equality**

- 1) Ali positioned himself as a champion for civil rights
- 2) The bout symbolized intersection of sports and social movements
- 3) Became what Ali's biographer called "the symbolic validation of what the 1960s stood for"

#### Strategic Wisdom vs. Raw Power

- 1) Ali's **"rope-a-dope" strategy** demonstrated intelligence overcoming physical advantages
- 2) Used tactical wisdom rather than matching Foreman's destructive power
- 3) Illustrates ethical principle of using discernment over brute force

#### **Reconciliation and Forgiveness**

- 1) Despite initially contesting results, Foreman developed deep friendship with Ali
- "I loved our relationship and to this day I still miss him" - Foreman
- Demonstrated transformation from rivalry to friendship

#### **Compassion and Human Dignity**

- 1) Years later, Foreman helped Ali with cuff links when showing early signs of Parkinson's
- 2) When criticized for this kindness, Foreman responded: "Joe, we are our brother's keeper"
- 3) Showed recognition of human dignity beyond competition

#### **Humility and Personal Growth**

- 1) Foreman's journey after defeat exemplifies transformation
- 2) Following religious experience in 1977, "anger, hate had been sucked out of my life"
- 3) Evolution from intimidating fighter to preacher showed moral development

#### **Authenticity and Self-Knowledge**

- 1) Both fighters navigated complex narratives about their identities
- 2) Struggled with and against imposed public identities
- 3) Reflected ethical challenge of maintaining authentic selfhood under scrutiny

#### Pune Porsche Tragedy: Outrage Over Lenient Penalty for Teenager in Fatal Accident

In Pune, a tragic accident involving a Porsche Taycan driven by a 17-year-old son of a prominent builder resulted in the deaths of two young software engineers, Aneesh Awadhia and Ashwini Koshta, on a motorcycle.

The teenager, who was accompanied by four friends, was subsequently detained by the Yerawada police and booked under relevant sections of the Motor Vehicles Act and Indian Penal Code. The police investigations revealed that the car was being driven at a speed of 160 kmph at the time of the crash, and CCTV footage showed the teenager consuming alcohol at a pub before the accident.



Integrity as a civil service value means being honest, trustworthy, and having strong moral principles in all your actions and decisions. At its core, integrity is about **consistency between what you think, say, and do**. For civil servants, this means:

- 1) Being honest and truthful in all dealings with the public, colleagues, and superiors2
- 2) Upholding ethical standards even when facing difficult situations or temptations4
- 3) Serving the public interest rather than personal gain2
- 4) Taking responsibility for your actions and decisions2
- 5) Being fair and impartial in treating all citizens without favoritism

"Integrity should not only be practised but it should be seen to be practised. The best measure of it is that it is practised when nobody is watching you" - Minister of State Jitendra Singh

## K.K. Pathak - Standing Against Political Interference

IAS officer K.K. Pathak resigned from the Indian Civil Service in protest against political interference. This act of unwavering honesty set a high standard for ethical conduct in public service, demonstrating that integrity means choosing principles over career advancement when faced with unethical pressures.

#### T.N. Seshan - Ensuring Electoral Integrity

Former Chief Election Commissioner T.N. Seshan is remembered for his integrity and impartiality in conducting free and fair elections. He ensured that every citizen's vote counted regardless of their background or affiliations, upholding the democratic process despite facing significant political pressure.

#### Kiran Bedi - Accountability in Action

Former IPS officer Kiran Bedi, who later joined the IAS, is known for her people-centric approach and strong work ethic. She faced public scrutiny during her tenure but maintained accountability and transparency, upholding her commitment to ethical service even when under intense public examination.

#### **Ashok Khemka - Fighting Corruption**

IAS officer Ashok Khemka is known for his fight against corruption in land deals. His exemplary work restores public trust in the



Laws, Rules, Regulations and Conscience as Sources of Ethical Guidance; Accountability and Ethical Governance; Strengthening of Ethical and Moral Values in Governance;



**Laws:** Codified values enacted by legislature with legal enforcement Examples:

- 1) Sati Abolition Act (1829) guided society toward progressive ethics
- 2) Section 377 decriminalization (2018) Supreme Court striking down homosexuality criminalization
- 3) Protection of Women from Domestic Violence Act

Impact/Significance: Progressive laws can guide ethics and make society more evolved; provide legal framework for moral conduct

**Rules:** Administrative directives for organizational functioning Examples

1) All India Services (Conduct) Rules, 1968

- 2) Indian Civil Services Act (1861)
- Workplace dress codes and professional conduct guidelines

Impact/Significance: Ensure disciplined administration and professional behavior; bridge gap between laws and daily operations

**Regulations:** Detailed requirements to reshape specific behaviors Examples

- 1) Wildlife Protection Act
- 2) Forest Conservation Act
- 3) Water (Prevention and Control of Pollution) Act
- 4) Environmental regulations for industries

Impact/Significance: Protect natural resources and public health; provide specific implementation mechanisms

**Conscience:** Internal moral guidance system Examples

- 1) Ashok Khemka exposing corruption in Haryana
- 2) Sanjeev Chaturvedi's anti-corruption stance
- 3) Durga Shakti Nagpal's action against sand mafia in UP
- 4) Civil servants helping undocumented poor citizens

Impact/Significance: Enables ethical behavior beyond legal requirements; crucial for situations where laws are silent or inadequate

#### Should assisted dying be legalised?

Why in News? The UK House of Commons voted in favour of legalizing assisted dying for terminally ill adults in England and Wales, signalling a significant shift on this ethically complex issue.

#### Arguments in Favour

- 1) Autonomy: Respects individual choice in end-of-life decisions
- 2) Suffering Relief: Alleviates unbearable pain when palliative care falls short
- Dignity Preservation: Allows control over manner and timing of death
- 4) Quality of Life: Prioritizes life quality over quantity in terminal cases

#### **Arguments Against**

Sanctity of Life: Violates fundamental moral principle

## Characters Demonstrating Integrity and Righteousness

- Lord Rama Embodied perfect ethical conduct and never compromised on moral values, earning the title Maryada Purushottam (the perfect man)46
- Lakshman Demonstrated unwavering loyalty by willingly giving up worldly luxuries to accompany his brother Rama during 14 years of exile1
- 3) Bharata Refused to sit on the throne and rule Ayodhya, recognizing Rama as the rightful heir despite unfair banishment1
- 4) **Prahlada** Showed unwavering faith and devotion to Vishnu despite his father's attempts to kill him for his beliefs3
- 5) **Shravana** Exemplified filial duty by carrying his blind, elderly parents on pilgrimage and requesting water for them even with his dying breath

#### **Stories Teaching Professional Ethics**

- Duryodhana consulting Sahadeva -Demonstrated professional ethics by seeking astrological advice from an enemy camp member for the most auspicious time to start war6
- 2) The Butcher's Virtue A butcher earned a place in heaven through respectful conduct toward his old, infirm parents despite his apparently sinful profession6
- 3) **Arjuna's moral dilemma** Faced the conflict between warrior duty and killing kinsmen, learning about dharma (righteous duty) from Krishna in the Bhagavad Gita

#### **Characters Showing Strength and Patience**

- 1) **Goddess Durga** Demonstrated that women possess great courage, strength, and righteousness by defeating the demon Mahishasura3
- 2) Mandodari Showed patience and loyalty by continuously trying to convince her husband Ravana to be just and honorable, even asking him to free Sita

Stories Highlighting Ethical Failures
Bhishma and Dronacharya's silence - Their
failure to speak during Draupadi's disrobing
despite knowing the correct moral stand
serves as a lesson about the importance of
standing up for justice.

#### **Ethics and Historical figures**

#### **Ancient Period**

- Buddha (563-483 BCE) Established the Five Precepts emphasizing non-violence, honesty, sexual integrity, truthful speech, and mental clarity; taught that ethical behavior leads to enlightenment and reduces suffering.
- Chanakya (350-275 BCE) Known as the "Indian Machiavelli," developed statecraft principles balancing pragmatic governance with moral responsibility in his Arthashastra.
- Valmiki Called "Adi Kavi," transformed from a dacoit to sage, demonstrating redemption through ethical transformation while composing the Ramayana.
- 4) Ashoka the Great (304-232 BCE) Created an "ethical infrastructure" by ending animal sacrifices and royal hunting, declaring "no living being is to be sacrificed or harmed" throughout his empire.

#### Pre-Independence Era

- 1) Rabindranath Tagore (1861-1941) Advocated ethics based on "divine harmony and love" rather than caste duty; emphasized social altruism over state criticism, writing "Man does not have to beg for his rights, he must create them for himself".
- 2) Dadabhai Naoroji (1825-1917) Called the "Grand Old Man of India," pioneered economic ethics by exposing British wealth drain in "Poverty and Un-British Rule in India" (1867), demonstrating moral courage in challenging imperial exploitation.
- 3) Gopal Krishna Gokhale (1866-1915) Founded the Servants of India Society, advocating self-governance through ethical service and education reform; mentored Gandhi in combining political action with moral principles.
- 4) Mahatma Gandhi (1869-1948) Developed Satyagraha combining truth (Satya) and non-violent resistance (Agraha); believed "self-sacrifice was the law of life" and made his entire existence an "experiment with truth".





- 5) **Nayak** Examines the challenges of maintaining ethics while navigating political power
- 6) **Mr. Smith Goes to Washington** Champions moral integrity against institutional corruption
- 7) **Shool** Demonstrates the personal cost of maintaining honesty in a corrupt system
- 8) Rang De Basanti Shows how civic consciousness can drive youth toward ethical governance
- 9) All the President's Men Underscores the importance of transparency and accountability in democracy

Agriculture - KM Sarayu (Krishnagiri, Tamil



#### Nadu)

Helped farmers take their produce to global markets, implementing initiatives that transformed local agricultural practices and improved farmer livelihoods.

## Healthcare - Pushpendra Kumar Meena (Durg, Chhattisgarh)



Spearheaded mental health awareness by screening 3.4 lakh rural households and treating over 2,900 mental health patients. His team stabilized a schizophrenic girl and identified multiple potential suicide cases. He overcame significant challenges including rural mental health stigma and trained district staff to identify mental health issues. He described his award as being about "lives saved".





#### A HANDBOOK FOR SOLVING ETHICS CASE STUDIES

#### 1: Case Studies based on Public Sector

#### Theme 1.1: Following rules vs acting with compassion

Cases illustrate the tension between strictly enforcing rules and acting with empathy towards citizens. Examples:

- 1) **2016 Question:** Where enforcing eligibility criteria would deny support to a needy woman, but making an exception would violate rules.
- 2) **2018 Question:** Where strictly enforcing all tax rules would hamper a much-needed charitable hospital, but ignoring minor defaults could set a wrong precedent.

#### **Standard Answer Dimensions**

#### **Ethical Issues/ Dilemmas Involved**

- 1) Regulatory Compliance vs Compassionate Governance: Balancing regulations with individual circumstances.
- 2) **Equality vs Equity:** Treating everyone the same vs adjusting responses based on needs.
- 3) Institutional Integrity vs Moral Imperatives: Upholding rules vs addressing moral obligations.
- 4) Public Welfare vs Rule of Law: Balancing welfare with law enforcement.
- 5) Long-term vs Short-term Solutions: Immediate problem-solving vs sustainable solutions.
- 6) Consistency vs Flexibility: Ensuring uniform rule application vs adapting to unique cases.
- 7) Transparency vs Confidentiality: Maintaining openness vs protecting individual privacy.

#### **Available Options before the Decision Maker**

**Option 1: Rigorous Rule Adherence:** This approach, grounded in deontological ethics, prioritizes institutional integrity and the rule of law.

Pros	Cons

**Option 2: Exceptions Based on Empathetic** Understanding: This option, inspired by consequentialist ethics, focuses on maximizing welfare outcomes.

**Option 3: Consultative Review of Rules:** This proactive approach involves a comprehensive review of the existing rules through engagement with stakeholders.

Pros	Cons
	Could be time-consuming; may lead to conflicts among stakeholders; no immediate relief provided.

**Option 4: Rule Revision and Policy Change:** Advocating for policy change if existing rules are restrictive or unjust, upon review.

Pros	Cons
Provides a long-term solution; sets a positive precedent for institutional reform; maintains institutional integrity while addressing societal needs.	resistance from stakeholders; no immediate relief

#### **Best Option**

The combination of the third and fourth options generally represents the best route for decision-making because:

- 1) **Inclusive Approach:** Balances institutional enforcement with societal compassion.
- 2) Adaptive Governance: Encourages institutional evolution and responsiveness.
